#### Section 6: Accidental Release Measures

Exclude non-essential personnel. Avoid breathing vapours. Refer to protective measures listed in sections 7 and 8. ### Section 7: Handling and Storage

#### Handling

#### Storage

### Section 8: Exposure Controls / Personal Protection
